



Security

We work closely with government and industry bodies and our cyber security consultants can advise on best practice.

Information security is of increasing importance to all organizations and we are market leaders in developing products and certifications which protect and defend information from cyber attacks.

We pro-actively monitor and protect our own systems and we hold a Cyber Essentials Plus Certification. APMG is not permitted to be certified to the information security standard ISO/IEC 27001 but we have invested heavily in compliance to this standard and external validation.

Transparency

Working in partnership with you, APMG provides a transparent service with real time reporting for updates and provisions.

APMG will appoint a project manager to capture your requirements and work with you to deliver your scheme. Once operational, you will be assigned a Product Owner who will be your main point of contact. By working with you and other members of the APMG team, including our global network of Business Development Managers and Marketing teams, you will be assured of the successful delivery and ongoing growth of your product.

Through regular meetings we will review the progress of your scheme and plan for future success. You will also be given access to an online

APMG has an established global network of over 40 assessors who can apply consistent and rigorous assessment standards in a professional and customer friendly manner. We have assessed over 500 organizations worldwide in over 20 languages.

Quality Management System

The Quality Management System (QMS) assessment ensures that the training or consulting organization effectively manages the service offered. Our assessment covers everything necessary for a good customer experience. This includes internal governance and the management process needed to check the organization consistently delivers, evaluates and improves their service provision.



The initial assessment will include a review of the processes by an experienced APMG QMS assessor. They will check all elements exist and are mature for the organization. Within the first year of accreditation, APMG will also complete an in-depth audit with the company to ensure they can demonstrate the successful and regular implementation of their QMS.

Regular surveillance activities are undertaken by APMG to ensure on-going compliance to the QMS requirements. At the end of the certification process, a further in-depth audit is completed to confirm full compliance is maintained.

Courseware and Consulting materials

Courseware and consulting materials to support the scheme will be reviewed by APMG. It is essential that the customer will be provided with sufficient materials to attain success in their assessment.

APMG will carry out a full assessment on the materials the Accredited Organization plans to use and determine if minimum levels have been met.

APMG can assess materials in a variety of formats including in-room and online delivery. We also monitor new technology and delivery methods used within the industry to ensure our assessment criteria evolve.

After courseware and consulting materials have been approved, APMG will work with the Accredited Organization to monitor and review amendments to content including changes to the delivery method

or translations. This ensures quality is maintained throughout all delivery channels.



Personnel Assessment - Trainers and Consultants

The final element of assessment for Accredited Organizations is their trainers or consultants. These individuals are crucial to ensure successful delivery to the customer.

Every APMG approved trainer and consultant has been witnessed by an APMG assessor who assesses technical knowledge plus training or consulting skills. This focus on their competence is unique to the markets in which we operate. After initial approval, the personnel certification is maintained through regular surveillance assessments with an in depth assessment conducted at the end of the five year accreditation cycle. Registrations

APMG can register and obtain trademarks for your IP, such as logos and straplines. Understanding the nuances of class registration and pre-existing registrations can be a minefield to those new to the system, especially if working outside your own country. License Issue

If APMG is unable to achieve a compliant solution with a company misusing IP, it can progress these discussions to an agreed stage and then pass all information to you for further action as desired.



Account Management


